Dear Mr. Dalzell:

Recent issues involving Diablo Canyon Power Plant (DCPP) classifications not included in the Electrical Technician Line of Progression were discussed between the Company and the Union and an agreement was reached as detailed below.

This Letter Agreement modifies and supersedes Letter Agreement R1-13-76, Job Definitions and Lines of Progression (JDLOP), Division Electric Maintenance Department, for Exhibit VI-L and Section 600.12, regarding the Electrical Technician Line of Progression (LOP), as follows:

1. The Apprentice Electrical Technician (SAP Code: 50010406) list of Same or Higher Classifications within the LOP will be updated to include:
 - a) Electrical Control Technician – DCPP (SAP Code: 50010386),
 - b) Unassigned Electrical Control Technician – DCPP (SAP Code: 50073008)
 - c) Electric Maintenance Subforeman - DCPP (SAP Code: 50073079)
 - d) Telecom Crew Foreman – DCPP (SAP Code: 50073073)
 - e) DCPP Senior Telecommunications Technician (SAP Code: 52450823)

The parties agree to award the existing Apprentice Electrical Technician bid (Bid Requisition #50161) to the Traveling Electrician - DCPP who already accepted the bid.

The parties also agree all DCPP contracting and flexibility issues will be discussed by the recently established DCPP flexibility subcommittee at DCPP.

Letter Agreement R1-13-76 will be updated, as set forth above, during the next revision of the JDLOP for the Division Electric Maintenance Department.
