Dear Mr. Dean:

In the first quarter of 2021, the Company received final CPUC approval to close ten (10) Customer Service Offices (CSO) as addressed in LA 20-07. Company and Union recently met to discuss the Company's intent to keep the remaining 65 Customer Services Offices (CSO) permanently closed. Official closing would take place no sooner than 60 days following the CPUC decision.

The Company has recognized annual declines in customer use of Local Offices over the last decade and following the temporary closures brought on by Covid-19 Safety protocols, customers have found alternative methods to pay their bills. Following thorough analysis of the COVID-19 impact to local offices, the Company intends to close the identified local offices included in Attachment I.

In accordance with Section 19.12 of the clerical agreement, the Company proposes the below options to address the impacts to affected CSO employees headquartered at the 65 Customer Service Offices.

All IBEW bargaining unit CSO employees in the identified 65 headquarters will be given Section 19.1(a) notification as soon as possible, which affords them priority bidding rights ("A" rights). Contingent upon CPUC approval, impacted employees shall be given a displacement option form no less than 30 days prior to any pending closures and shall be provided a minimum of 14 calendar days to complete the form, indicating their voluntary preferences as follows:

- 1. Remain in the same classification and transition to a position focused on supporting customers with outbound calling, supporting local customer events and inbound calls as required.
 - a. Employees who are able to successfully work remotely will be allowed to do so, in accordance with Letter Agreement 21-01.
 - b. It is the Company's intent that employees will remain assigned to their current headquarters however in the event a facility is permanently closed, employees will be reassigned to a new headquarters. The Company will make every attempt to reassign incumbent employees to a PG&E headquarters within a commutable distance from the incumbent employee's residence and where office space is available.
 - c. Incumbent Employees identified in Attachment 2 that are designated as Part-Time or Intermittent may elect to: 1) Remain in the same classification in their respective Part-Time or Intermittent status; or 2) Remain in the same classification and accept a Full-Time position.
- 2. Accept a position within the same classification at the Fresno Contact Center or Sacramento (2740) Gateway Oaks Contact Center.
 - a. Employees who are able to successfully work remotely will be allowed to do so through the end of COVID-19 working conditions, as determined by the Company. The parties are currently discussing

possible long term remote working conditions and any agreement reached would be applicable to these employees.

- b. Employees who are not able to successfully work remotely will be required to report to their newly assigned headquarters no sooner than 30 days after the notification of option award.
- c. Employees who accept this option will remain on their existing shift until the next center-wide shift bid at which time shifts will be awarded based upon headquarters, classification, and seniority.
- 3. Other identified entry level vacancies within the Clerical & Physical bargaining units. Employees must meet qualification requirements at the time of election. Such identified vacancies will be communicated to employees as soon as practicable.
 - a. Impacted employees shall have their rate of pay frozen, in accordance with the provisions of Section 13.9(d) of the clerical agreement, following notice of displacement and who elect to vacate their position through bid, transfer, or election of a position with a lower wage scale in accordance with Option 2 above.
- 4. Voluntary layoff with severance pay in accordance with Exhibit K and Section 19.7(b)

Impacted employee elections, as outlined in options 1-4 above, will be determined by Company seniority and shall be binding upon notification of awarded election.

The provisions of Section 19.8 Moving Allowance shall apply to this agreement as applicable, and the reimbursement maximum allowed for moving expenses shall be \$5,000 based on submission of qualifying expenses in accordance with this section of the clerical agreement.

The Company and Union will work together to ensure employees are fully informed and educated prior to making their elections. The parties will work together to answer any questions and/or resolve any issues that arise out of this process. Report dates and severance dates will be determined by the Company and are expected, based on operating need, to coincide with the actual closure of the Customer Service Office where the employee is headquartered.

This proposal has been discussed with Senior Assistant Business Manager Bryan Carroll.
