Dear Mr. Dean:

The Company and IBEW Local 1245 recently discussed the parties' shared commitment toward driving safety. Specifically, the discussion focused on a joint agreement of a pilot program utilizing the Nauto system of incident based in-cab camera technology.

The Company will begin this pilot in the Winter/Spring 2022 and the pilot is expected to last approximately six months once installations are complete. The pilot program will consist of 500 participant vehicles and will be made up of both non-represented and IBEW 1245 represented employees. Only PG&E owned vehicles will be utilized for the pilot program.

The parties agree to each appoint three members to be a part of an Oversight Committee that will meet regularly during the pilot to review and resolve any specific concerns and to discuss the results of the pilot.

The pilot locations are not yet defined but will be in three Division areas and a Hydro Generation area that represent the different driving conditions across the PG&E system. Prior to any implementation of the pilot described in this agreement, both joint and individual communications sessions shall be held by both parties with the potentially impacted employee groups so as to thoroughly communicate details related to the pilot. While the parties agree to solicit volunteers for the pilot as a first option, it may become necessary to assign vehicles to the pilot to minimize locations and conditions of the pilot locations. Should this occur, the Company will notify the Oversight Committee prior to making any assignments.

Safety is of the utmost importance to both parties and the intent of this pilot agreement is to promote safe driving habits and to gather data which will be used to coach and fill gaps which may exist.

During this pilot, the Company agrees not to utilize the information provided by this technology for disciplinary purposes. The parties agree to discuss the use of this technology with regards to discipline at the conclusion of the pilot should the technology be implemented.
