Dear Mr. Dean:

In accordance with Sections 19.12 of the Clerical agreement and 206.12 of the Physical agreement, the parties have discussed headquarter reassignment for IBEW represented classifications within both the Clerical and Physical agreements who are currently headquartered at 3401 Crow Canyon Blvd., San Ramon, due to closure of this facility in Q2 2022, and have agreed to headquarter reassignment of impacted IBEW represented employees as outlined in Attachment 1 of this agreement.

In addition to employees headquartered at 3401 Crow Canyon Blvd., San Ramon, the parties recognize the intended closure of the Concord RMC prior to end of year 2023 and agree to reassign two clerical employees assigned to the L&EM Clerical Management team from the Concord RMC to the identified headquarters as outlined on Attachment 1 as part of this agreement.

Due to the ongoing phased occupancy of the Oakland General Office through 2023, the Company proposes to reassign the impacted employees who will be headquartered at the Oakland General Office, 300 Lakeside Drive, based on the scheduled move timelines of the employee's specific Line of Business (LOB). Relocation of one Operating Clerk in the L&EM Clerical Management team to the 2730 Gateway Oaks, Sacramento, as identified in Attachment 1 of this agreement, shall be effective as soon as administratively possible following the signing of this agreement. Furthermore, the parties agreed that the two employees currently headquartered at the Concord RMC, as identified in Attachment 1, may voluntarily remain assigned to the Concord RMC until the Company exits the facility some time prior to 2024 based on Company communicated closure date.

IBEW represented members who are covered by this agreement as identified in Attachment 1 will be given Section 19.1(a) and 206.1(a) notification as soon as practicable which affords the impacted employees priority bidding rights ("A" rights).

Upon execution of this agreement and following notice of displacement, impacted employees who elect to vacate their position through bid or transfer to a position with a lower wage rate, strictly as a result of this headquarter reassignment, shall have their wages frozen in accordance with the provisions of Sections 13.9(d) of the Clerical agreement and 204.6(d) of the Physical agreement upon reporting to their new classification. Such bid/transfers must be awarded prior to relocation to the newly assigned headquarters.

The provisions of Sections 19.8 and 206.8 Moving Allowance of the Clerical and Physical agreements respectively, apply to this agreement as applicable and the reimbursement maximum allowed for moving expenses shall be \$5,000 based on submission of qualifying expenses.

This agreement has been discussed with Sr. Assistant Business Manager Bryan Carroll and Business Representative Gracie Clark.
