The Company and Union recently met to discuss California Occupational Safety and Health Regulations (CAL/OSHA) License Requirements for Crane and Derrick Certification and the Utility Exemption which allows utilities the ability to self-certify equipment. This self-certification requires the need to have a highly trained and competent professional crane surveyor workforce, licensed by the state of California, to help PG&E become the safest most reliable utility in the country.

The parties agree that there is a realization of benefits to both parties by establishing a new Crane Surveyor Line of Progression within the Field Employees - General Construction Line of Progression to engage in the testing, examination and/or certification of cranes.

Pursuant to Section 304.4 of the Physical Agreement, Company and Union propose to revise the Job Definitions and Lines of Progression for the Field Employees - General Construction by establishing a new Line of Progression (LOP) titled Crane Surveyor. The LOP will include one beginning level position titled Crane Surveyor in Training; and two above entry level positions titled Crane Surveyor and Working Leader B – Crane Surveyor. The classifications will be added to the Field Employees - General Construction Line of Progression, Section 600-13, Exhibit VI-M, with the next scheduled update to the Job Definitions and Lines of Progression (JDLOP). (Attachment 1)

The job descriptions and Lines of Progression for the Crane Surveyor in Training, Crane Surveyor, and Working Leader B – Crane Surveyor are provided in Attachment 2.

#### **DEPARTMENT OF TRANSPORTATION REQUIREMENTS:**

The classifications included in this agreement are covered by the Department of Transportation requirements as outlined in applicable Letter of Agreements, and all provisions that apply under the Federal Motor Carrier Safety Administration (FMCSA), including pre-duty drug testing.

#### JOB BIDDING & TRANSFER/PROMOTION (TP) PROCESS

#### Crane Surveyor

When filling Crane Surveyor vacancies, the parties agree to modify Subsection 305.5(c) allowing a Crane Surveyor in Training, who does not maintain the required qualifications, an accelerated opportunity to obtain the California OSHA Crane Surveyor License; Mobile Cranes (M), prior to submitting a permanent upgrade form. Crane Surveyors in Training who successfully obtain their license may be considered through the TP process prior to meeting the wage requirements for auto-progression. Upon exhausting this classification, the Company will utilize the normal provisions of Title 305.

#### Working Leader B - Crane Surveyor

Promotional opportunities for internal candidates who hold the Working Foreman B classification (50251367) within Transportation Services will be pending upon successful completion of California OSHA Crane Surveyor License; Mobile Cranes (M)

Note: Company shall pay the cost of the California OSHA Crane Surveyor License; Mobile Crane (M) certification and required recertifications.

#### **TRANSITION OF INCUMBENTS:**

#### Field Mechanical Inspector (50010230) Notes:

- A. Upon execution of this Agreement, incumbent Field Mechanical Inspectors who currently possess a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) and volunteer within 30 days from the effective date of this agreement to maintain a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) shall be reclassified to the Crane Surveyor classification and shall receive the corresponding wage rate retroactive to the effective date of this Agreement (Attachment 4).
- B. An incumbent Field Mechanical Inspector who currently possess a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) and does not volunteer within 30 days from the effective date of this agreement to maintain a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) shall remain in the Field Mechanical Inspector classification.
- C. Incumbent Field Mechanical Inspectors who did not volunteer as noted above are not precluded from being awarded a Crane Surveyor vacancy through the TP or job bidding process in the future provided they meet the requirements prior to the vacancy control date.
- D. With the next scheduled update to the JDLOP, the parties will review and discuss occupancy of the Field Mechanical Inspector classification to determine the relevance of designating the classification as "Present Incumbent Only" (PIO).

#### Working Foreman B – Non Climbing (50251367) Notes:

- A. Upon execution of this Agreement, incumbent Working Foreman B- Non Climbing, identified in Attachment 3, who currently possess a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) and volunteer within 30 days from the effective date of this agreement to maintain a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) shall be reclassified to the Working Leader B Crane Surveyor classification and shall receive the corresponding wage rate retroactive to the effective date of this Agreement (Attachment 5).
- B. An incumbent Working Foreman B Non Climbing who currently possess a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) and does not volunteer within 30 days from the effective date of this agreement to maintain a CAL/OSHA Crane Surveyor License; Mobile Cranes (M) shall remain in the Working Foreman B Non Climbing classification

C. Incumbent Working Foreman B – Non Climbing who did not volunteer as noted above are not precluded from being awarded a Working Foreman B – Crane Surveyor vacancy through the TP or job bidding process in the future provided they meet the requirements prior to the vacancy control date.

#### JOINT OVERSIGHT COMMITTEE

Issues that the Oversight Committee cannot resolve will be escalated to the Company's and Union's respective designees to attempt resolution within forty-five (45) days. Issues that the Oversight Committee cannot resolve will be subject to the party's grievance procedure Subsection 102.3(a)(2) and timelines will be waived for the forty-five-day period.

The Oversight Committee will meet as necessary to discuss technology advancement(s) as it relates to drones and this Letter Agreement.

This agreement has been discussed with Anthony Brown, Senior Assistant Business Manager and Mike Adayan, Assistant Business Manager.



JOB DEFINITIONS Attachment 2

#### **WORKING LEADER B – CRANE SURVEYOR**

53002120

An employee who is a working leader. May oversee a group of Crane Surveyors and/or mechanics including themself, are employed and where such employees are engaged in tool, equipment, and automotive maintenance and repair. Employee will be responsible for reviewing work performed by mechanic overseeing adhering to regulatory and company guidelines. Shall have the personal qualifications of the leader and supervisory ability, the crane qualifications of a Crane Surveyor or Field Mechanical Inspector and be familiar with the company's safety standards, accounting procedures, and other rules and regulations.

#### Requirements:

- Possess and Maintain California OSHA Crane Surveyor License; Mobile Cranes (M)
- May be required to possess a valid Class A Driver's License for the convenience of the Company, pursuant to Letter Agreement 12-32.

Note: Company shall pay the cost of the California OSHA Crane Surveyor License; Mobile Crane (M) certification and required recertifications.

#### **CRANE SURVEYOR**

53002119

An employee who without direct supervision performs testing, examination and/or certification of cranes used in lifting service exceeding three tons rated capacity; They shall have the craft qualifications of an Equipment Mechanic. They must be able to operate properly all types of vehicles and construction equipment and to impart this knowledge to other employees.

#### Requirements:

- Possess and Maintain California OSHA Crane Surveyor License; Mobile Cranes (M)
- May be required to possess a valid Class A Driver's License for the convenience of the Company, pursuant to Letter Agreement 12-32.

Note: Company shall pay the cost of the California OSHA Crane Surveyor License; Mobile Crane (M) certification and required recertifications.

#### **CRANE SURVEYOR IN TRAINING**

53002118

An employee who specializes in hydraulic and electronic over hydraulic control systems and who without direct supervision performs inspection and/or repairs to cranes used in lifting service; as well as all types of vehicles, construction equipment and appurtenances, including hydraulic, and electrical circuits and devices, and makes reports thereon; inspects vehicles or equipment being assembled, fabricated or repaired to make sure that they meet Company's and manufacturer's specifications; recommends payment of invoices, and initiates claims and adjustments and is responsible for preparation of Estimate for Repair or Replacement forms (or other form which may in future replace this form). They shall have the craft qualifications of an Equipment Mechanic. They must be able to operate properly all types of vehicles and construction equipment and to impart this knowledge to other employees.

#### Requirements:

• Crane Surveyors in Training who successfully obtain CAL/OSHA Crane Surveyor License; Mobile Cranes (M) and hold the top rate of pay (End 24 Mo Step) for 12 months will automatically progress to Crane Surveyor

- Crane Surveyors in Training who are unsuccessful in obtaining CAL/OSHA Crane Surveyor License; Mobile Cranes (M) within 36 months of obtaining the classification, shall be subject to the provisions of Title 306.
  - o If an employee is unable to obtain CAL/OSHA Crane Surveyor License; Mobile Cranes (M) within the 36-month period, it will be referred to the Oversight Committee, prior to provisions of Title 306.
- May be required to possess a valid Class A Driver's License for the convenience of the Company, pursuant to Letter Agreement 12-32.

#### Testing Requirements:

Must pass applicable tests/test batteries as agreed to by the Company and Union, which may include the Work Orientation Inventory, Physical Test Battery, Industrial Skills Test, or new tests deemed appropriate and agreed to by the parties.

Note: Company shall pay the cost of the California OSHA Crane Surveyor License; Mobile Crane (M) certification and required recertifications.
