Dear Mr. Dean:

In accordance with Sections 19.12 of the Clerical agreement and 206.12 of the Physical agreement, the parties have discussed headquarter reassignments for IBEW represented classifications within both the Clerical and Physical agreements who are currently headquartered at the Concord RMC, 1850 Gateway Blvd., Concord, and Bishop Ranch Building Y at 6111 Bollinger Canyon Rd., San Ramon, due to closure of these facilities. The parties agree to the following:

IBEW bargaining unit members as identified in Attachment 1 of this agreement have been given Section 206.1(a) and 19.1(a) notification effective February 9, 2023, which affords the impacted employees expanded priority bidding rights ("A" rights) as outlined in this letter agreement.

This agreement is not intended to modify any contractual provisions provided in the IBEW Physical and Clerical agreements or Letter Agreement R2-22-22 provisions for hybrid/remote work other than those outlined below.

Headquarters Selection Process

As the company continues to reduce its real estate footprint in the Bay Area and surrounding locations,

available space at other headquarters in the immediate Demotion Areas to these facilities is not available, however the following headquarters options will be provided to impacted employees, as identified in Attachment 1 of this agreement, to elect as their regularly assigned headquarters:

- Oakland General Office, 300 Lakeside Drive, Oakland
- Stockton Regional Center, 3136 Boeing Way, Stockton
- W. Sacramento RMC, 850 Stillwater Rd., W. Sacramento

A headquarters selection form will be provided to impacted employees identified in Attachment 1 of this agreement for employees to submit their headquarters selection preference. All impacted employees, whether designated as Hybrid or Onsite shall submit a Voluntary Headquarters Option form, ranking the three headquarters options in order of priority preference. Any employee not submitting the form by the communicated due date will have the Oakland General Office assigned as their new headquarters. The Stockton Regional Center and W. Sacramento RMC have a pre-determined maximum headcount allotment for headquarters assignment of these impacted employees, therefore if employee voluntary elections for either of these locations are in excess of the maximum availability, employees will be awarded their location preferences in order of company seniority and their listed headquarters preference. The maximum available capacity for assignment under this agreement to the Stockton Regional Center is 17 and W. Sacramento RMC is 15.

Headquarter Assignment Date

Due to the ongoing phased occupancy of the Oakland General Office (OGO) through 2023, impacted employees whose new headquarters will be OGO will be reassigned based on the scheduled move timelines of the employee's specific reporting Department. Those employees who elect either Stockton or W. Sacramento locations, will be reassigned as soon as administratively possible following the signing of this agreement.

Travel Time, Commute Expenses & Mileage

Employees who elect and are awarded the Stockton Regional Center or W. Sacramento RMC as their company assigned headquarters through this agreement shall not be eligible for travel time, commute expenses, or mileage reimbursement as outlined in Sections 10.8 and 15.2 of the clerical agreement, Sections 202.22, 202.23 and 201.6 of the physical agreement, and applicable provisions of Letter Agreement R2-22-22 when required to report to the Oakland General Office at the direction of their leader for onsite meetings, required onsite work collaboration, and onsite trainings on their regularly scheduled workday up to a maximum of 6 days per month. Required onsite overtime assignments wholly outside of the employee's regularly scheduled work period, shall not be included in the calculation of 6 days per month. Contractual provisions under the identified Sections and Letter Agreement noted above shall be applied if an employee who is assigned to the Stockton Regional Center or W. Sacramento RMC through this agreement is required to report to OGO more than 6 days in a calendar month during a regularly scheduled workday, except as provided in the following.

The provisions outlined in LA R2-22-22 to return hybrid employees shall continue to apply to employees under this agreement. In addition, employees under this agreement who are assigned to the Stockton Regional Center or W. Sacramento RMC who are required by their leader to return to working onsite due to attendance, performance or conduct issues following the issuance of a Written Reminder or Decision Making Leave (DML) may be required, at the direction of their leader, to work onsite at the Oakland General Office for supervisory oversight when the supervisor is present at OGO to provide oversight. This requirement may also include employees under this agreement who are assigned or chose to work onsite at either W. Sacramento RMC or the Stockton Regional Center who due to performance issues need supervisory oversight while on active discipline of a Written Reminder or higher. In such cases, the modified travel time, commute expenses, and mileage provisions outlined in this agreement shall apply without limitation to 6 days per month as long as the employee is on active discipline. Once the employee is no longer on active discipline of a Written Reminder or DML, the employee will not be required to report to OGO beyond 6 days per month without applicable temporary headquarters expense provisions. If an employee's discipline is reduced below a Written Reminder through the grievance procedure, and the employee has incurred reduced expenses to report to OGO more than 6 times in a month, the employee shall be reimbursed for expenses in accordance with normal temporary headquarter provisions for each month the employee was required to report to OGO for supervisory oversight in excess of 6 days prior to the discipline being reduced below a Written Reminder in the grievance procedure.

Employees assigned to the Stockton Regional Center or W. Sacramento RMC under this agreement who leave their current classification or assigned company department as identified in Attachment 1 of this agreement through reassignment of reporting department at the headquarters, transfer, bid or unrestricted appointment will no longer be subject to these modified provisions when reporting to OGO.

Expanded Bidding Rights

IBEW represented employees who are covered by this agreement as identified in Attachment 1 are hereby given expanded Section 19.9 and 206.9 priority bidding rights ("A" rights) to established headquarters within the Clerical and Physical Demotion Unit One, Area Three and Area Four, within their current classification as of February 9, 2023. Additionally, employees identified on Attachment 2 of this agreement who were relocated from 3401 Crow Canyon Blvd., San Ramon, under Letter Agreement 22-20 shall be afforded the same expanded bidding rights as outlined in this agreement, effective upon implementation of this agreement.

In order for employees identified in Attachments 1 and 2 to maintain priority transfer/bid rights to any of the headquarters identified below, the employee must exercise every opportunity available to transfer/bid to the headquarters by maintaining active transfers/pre-bids on file. If an employee does not keep an active bid on file or declines a valid bid offer at the headquarters identified below where a position is being filled, the employee will forfeit their priority bidding rights for that headquarters. It will be the employee's responsibility to review the New Classification at Headquarters notifications to ensure transfers/bids are on file if a new bid code within the employee's current classification is established.
