Dear Mr. Dean:

On May 1, 2025, the Company and Union met to discuss a supplemental workforce agreement I.A.W. LA 24-32 and LA 24-33. Pursuant to LA R1-04-12, Section II, the Company and Union have worked together cooperatively to meet the objectives of both parties and have agreed to use Hiring Hall (HH) personnel as the source to supply any supplemental workforce. HH employees working under this agreement will not accrue service or gain regular status.

This pilot agreement will employ the use of the Special Project or Special Condition section of R1-04-12 to provide a process in which the LOB may call upon predesignated HH employees to support the regular status workforce at Helms and Balch. Some examples of support scenarios: (1) periods of time when an increased Camp population creates work demand (room and board services) beyond the straight time and overtime capabilities of the regular Status Camp Specialists. (2) Projects requiring additional maintenance or construction such as outages, increased workload beyond the straight time and overtime capabilities of the Camp regular status maintenance workers.

This pilot agreement will allow LOB to assign immediate support per the preapproved (by Labor and Local Business Rep) Hiring Hall Special Project or Special Condition form. (see attached example).

Both parties will reconvene to review and potentially edit the pilot process, and create a permanent agreement. This agreement expires 12 months after the signature date.
