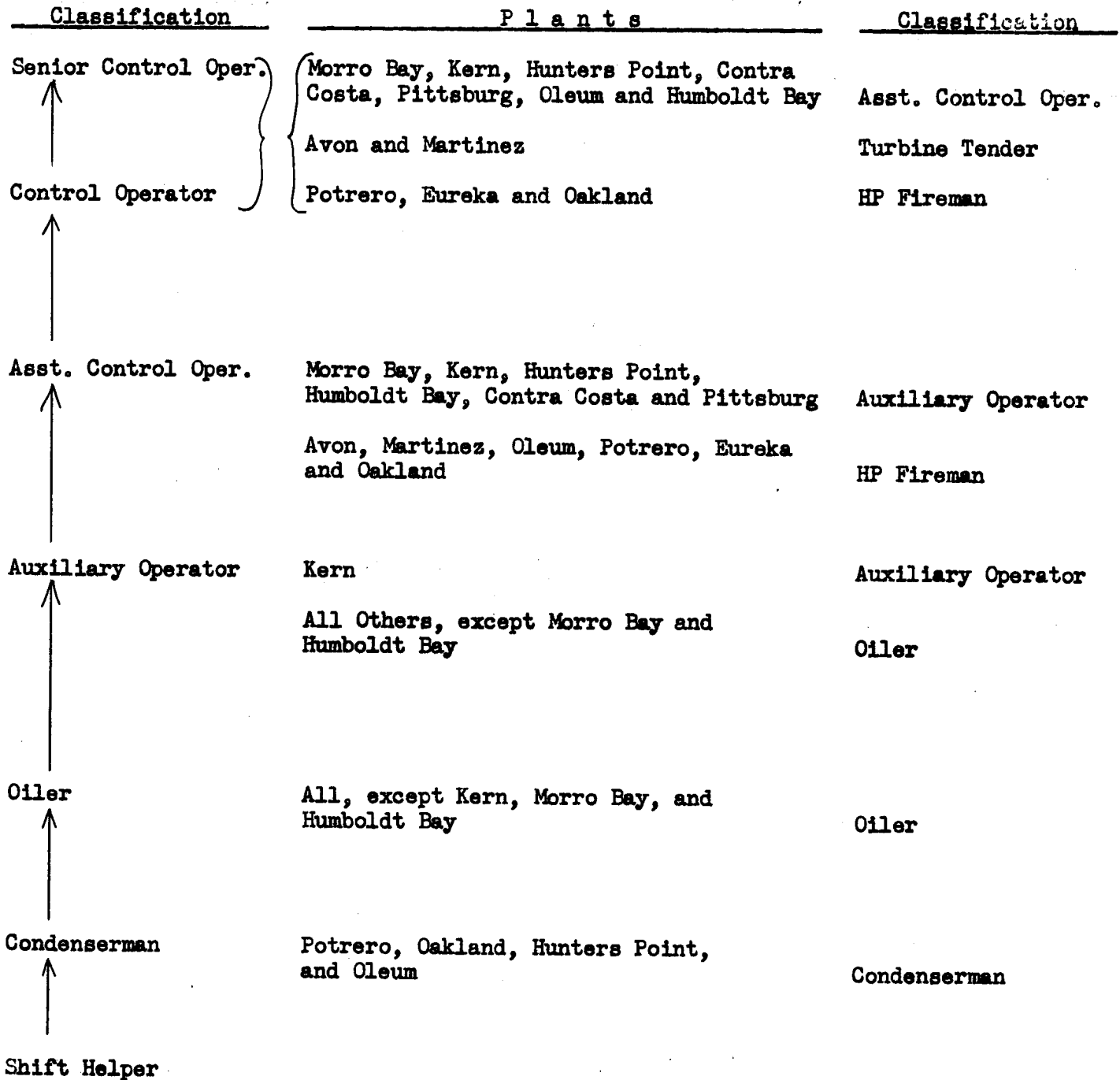

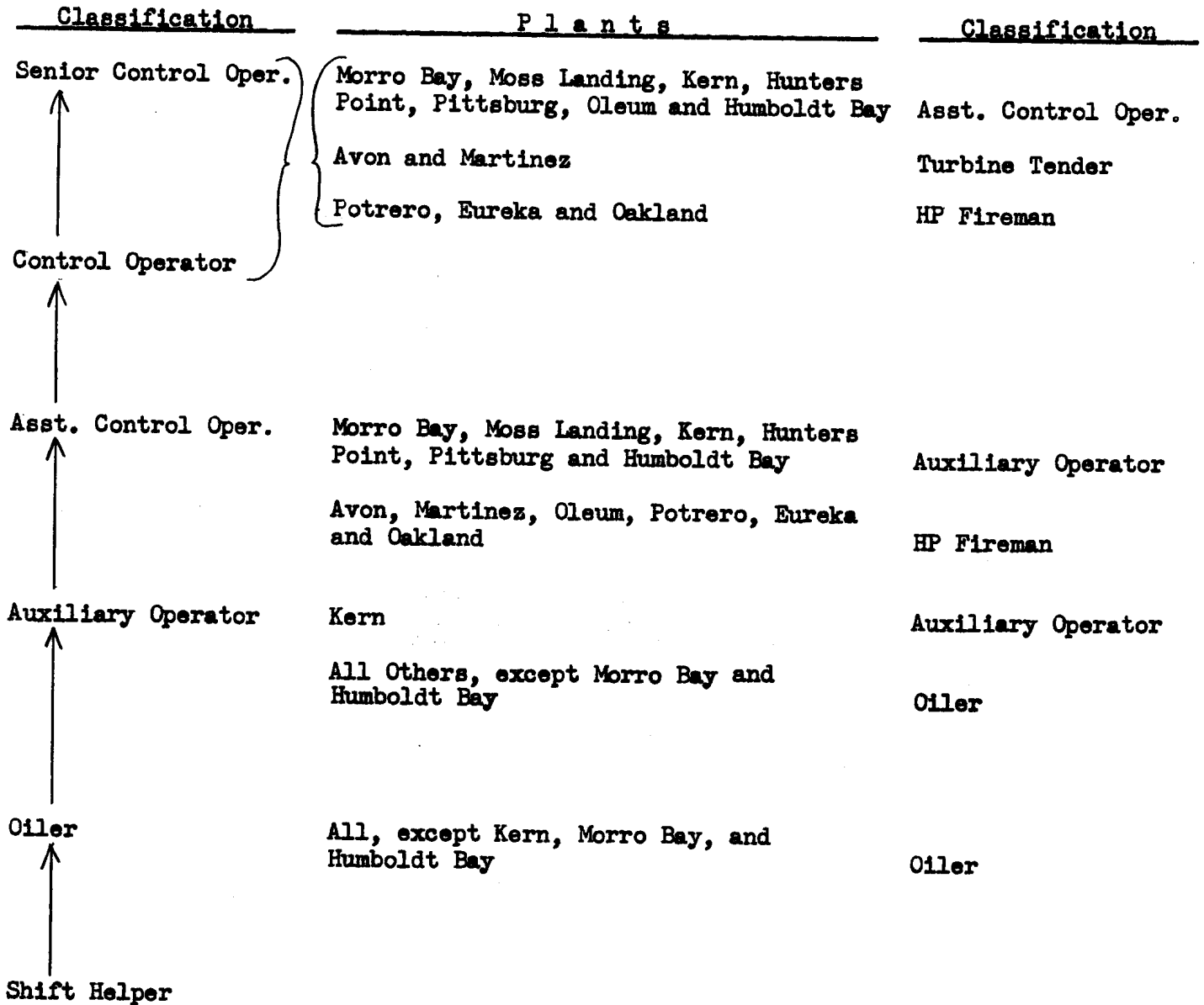

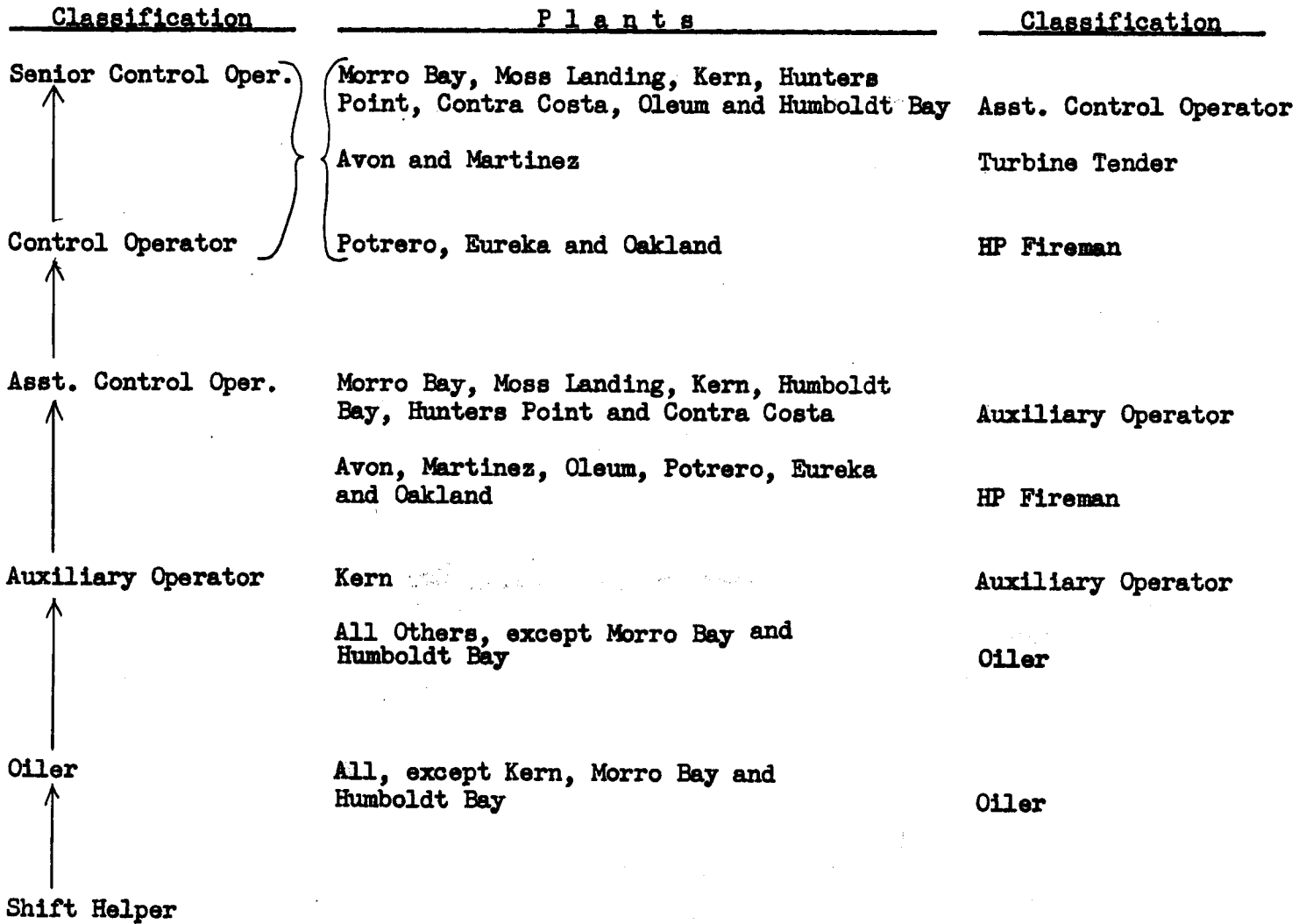

Notes: Employees who are in the classification of High Pressure Fireman, Shift Mechanic or Boiler Feed Pumpman at Potrero, or who have been demoted from such classifications due to lack of work as of the date of this supplementary agreement shall be considered as being in the next lower classification to Auxiliary Operator at Hunters Point.

The provisions of Section 205.8 of this Agreement shall not apply to employees classified as Oiler or Condenserman when they bid between Hunters Point and Potrero.
