Gentlemen:

Company will discontinue the classification of Water Treatment Subforeman which is currently held by Mr. B. E. Slade in Drum Division. This classification will no longer be needed upon the completion of the sale of the lower Drum water system to the Placer County Agency. In its place, Company proposes to establish the classification of Water Service Subforeman with the following job definition, wage rate, and line of progression.

0840 Water Service Subforeman

An employee who is a working foreman in charge of the operation and maintenance of the water treatment plants in his area; supervises the repair, maintenance, and operation of water level recorders, pumping plants and pressure systems; supervises and performs work related to providing and maintaining water service to the public; and, supervises and performs work related to the operation and minor repair of canals, flumes, gates, and other related facilities. He shall have the personal qualifications of leadership and supervisory ability, and the craft qualifications of a Water Treatment Operator and Water Subforeman, and be familiar with Company's operating standards, safety rules, accounting procedures, and other applicable rules and procedures.

Proposed wage rate: Start \$182.05 per week End 1 year \$192.00 per week

Same or Higher Classification

1897 Water Treatment Plant Operator I 0840 Water Service Subforeman

1900 Water Treatment Plant Operator II

1903 Water Treatment Plant Operator III

2190 Water Serviceman

This classification shall be considered the same or higher than all classifications listed in Exhibit VI-G Division Water Departments, except Helper and Field Clerk.

Under the provisions of Section 206.13, Company proposes to transfer Mr. B. E. Slade from Water Treatment Subforeman to Water Service Subforeman, effective

upon the discontinuance of the Water Treatment Subforeman classification at Auburn.
