

DEAR SIR:

I WOULD LIKE TO REQUEST A TRANSFER TO THE SAN JOAQUIN VALLEY DUE TO A SERIOUS ILLNESS OF MY FATHER, WHO LIVES IN MADERA.

THE WEEKEND OF JANUARY 12TH I HAD TO TAKE HIM TO THE HOSPITAL. THE DOCTOR SAID HE WILL NEED PLENTY OF REST AND TOLD ME TO KEEP HIM IN THE HOUSE AND IN BED. THE DOCTOR ALSO SAID IF HE DIDN'T FOLLOW THESE INSTRUCTIONS, HE WOULD PROBABLY HAVE TO GO BACK TO THE HOSPITAL.

I WOULD LIKE TO GET BACK IN THIS AREA TO TAKE CARE OF HIM. THERE IS NO ONE ELSE OF THE FAMILY THERE AND I HAD TO HIRE A NURSE TO TAKE CARE OF HIM. IT COST ME \$100.00 PER WEEK FOR THE NURSE, PLUS KEEPING UP ALL THE PAYMENTS. MY FATHER HAS BEEN UNABLE TO WORK FOR QUITE A WHILE AND THIS ADDITIONAL EXPENSE HAS MADE IT HARD FOR ME TO KEEP UP ALL THE EXPENSES AT HOME AND LIVE UP HERE.

I WILL WAIVE PER DIEM AS LONG AS I CAN GET CLOSE TO MADERA TO TAKE CARE OF MY FATHER.
