Gentlemen:

This proposal rescinds and replaces our proposal on this subject dated April 8, 1963.

Company eliminated the six First Service Operator positions in the Electric Department at Cupertino on May 4, 1963. On the same date, Company established four Service Operator and two First Service Operator positions in the Gas Department at San Jose. These positions are being filled temporarily on a basis of classification seniority by the six employees displaced at Cupertino.

Without reference to the bidding procedure, and in accordance with Section 206.1(e) of the Agreement, Company proposes to fill the four vacancies in the Senior Service Operator classifications at San Jose with four First Service Operators from within San Jose Division on the basis of classification seniority. Company further proposes to fill the two vacancies in the First Service Operator classifications at San Jose with the First Service Operators at Cupertino who are not placed in Senior Service Operator positions at San Jose. Company further proposes to place any First Service Operators remaining at Cupertino after the filling of the San Jose vacancies in vacancies elsewhere in the Division which have been created by movement into the San Jose positions.

Accordingly, the following is a tabulation of the reclassifications and relocations of First Service Operators under this proposal:
