In order to expedite the flow of necessary reports to the Divisions a change in the San Francisco mail messenger service routes (Pony Express) from a Monday-through-Friday schedule to a Sunday-through-Thursday schedule will be made. This will result in a change under the provisions of Section 202.15 of Light Truck Drivers assigned Pony Express routes to a Sunday-through-Thursday basic workweek.
