Gentlemen:

This letter cancels and supersedes our letter of July 29, 1976 concerning the hours of work for Communication Technicians in Shasta Division.

In order to properly perform maintenance on the communications system in Shasta Division, Company proposes, pursuant to Subsection 202.16(b) of the Physical Agreement, to establish rotating Tuesday - Saturday workweeks at all locations where Communication Technicians are headquartered in the Division during the period of April 25 - May 8 and October 24 - November 6, 1980. All available Journeyman Communication Technicians at each headquarters including any unassigned Journeyman shall be rotated through the Tuesday - Saturday schedule.

Company further proposes that during any week when a Company holiday other than an employee's birthday holiday falls on a Friday or on a Saturday or on the following Sunday or Monday, all technicians will be scheduled to work Monday through Friday, and Saturday will be considered a non-workday.

This Agreement may be cancelled by either party by giving thirty days' written notice to the other party. This proposal has been reviewed with Mr. R. M. Hafner, Business Representative serving Shasta Division and has his concurrence.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided below and return one executed copy of this letter to Company.
