Gentlemen:

Due to the increased demand on the Gas Distribution Department's training facility at Potrero, we are unable to schedule attendance of Apprentice Equipment Mechanics to the school in a timely manner.

Company has suitable facilities at the Peralta Street shop in Oakland in which to train General Construction Apprentice Equipment Mechanics in welding. In order to take some of the pressure off the Potrero training facility, Company proposes to train such GC Apprentices, as work at that headquarters, at the Peralta shop. Such training will satisfy the welding skill requirement for Apprentice Equipment Mechanic.

To insure that the apprentices at the Peralta facility receive training comparable to that provided to others at Potrero, the following provisions will apply:

- 1. Instruction in welding equipment safety be provided in an appropriate manner before the apprentice is allowed to operate the equipment. We recommend a classroom type lecture or discussion covering Accident Prevention Rules 24 and 25, and utilizing the written material (enclosed) which is presented at the Gas Distribution Department school.
  - a) SAFETY PRECAUTIONS booklet by UNION CARBIDE, #F-3499D
  - b) WELDING, CUTTING & HEATING GUIDE book by Victor
  - Note: Items (a) and (b) are available from the fuel gas and welding equipment suppliers
  - c) Handout sheets prepared by Mr. Hardy, Chief Instructor, should be included in the apprentice manual.
    - (1) Acetylene Cylinder
    - (2) Handling Burning Acetylene Cylinders
    - (3) Backfire and Flashback
    - (4) Important Don'ts

2. Final Weld testing is done by the General Construction-Gas weld inspector.

The GC Peralta Shop program is a modified on-the-job operation allowing the apprentice to progress at the individual's own pace and ability. They provide the apprentice with welding instruction in the shop and time to practice welding exercises.
