Gentlemen:

Gas Construction has commenced a job on Francisco Boulevard in San Rafael. The City authorities have requested that the work on this job be accomplished between the hours of 9:00 p.m. and 6:00 a.m., Sunday through Thursday (see attached 7/31/81 letter from the City of San Rafael). It is expected that the job will be completed within two to three months.

The change in regular work hours has been effected under the terms of Subsection 302.7(e)(1) of the Physical Agreement, and the crew assigned to the job now begins work at 9:30 p.m. and quits at 6:00 a.m.

Section 302.3 of the Physical Agreement provides that a different basic workweek of 5 consecutive days may be established by "Company's Foreman or other Supervisor and the employees involved, together with Union." The employees on the crew are agreeable to the proposed change (see attached letter dated 8/4/81). However, local Union representation has been reluctant to agree to the change. Therefore, Company proposes, for the IBEW Business Manager's agreement, pursuant to Section 302.3 of the Physical Agreement, to change the basic workweek of Gas Construction employees in San Rafael from Monday through Friday to Sunday through Thursday, for the duration of the above-mentioned assignment.
