Gentlemen:

Due to a previously unforeseen need to commit ten journeyman Cable Splicers, in San Francisco, to the PCB Transformer Replacement Program and the fact that an estimate of seven Cable Splicers will be lost due to retirement in 1984, Company proposes to provide accelerated academic and on-the-job training to 12 employees currently in the Apprentice Cable Splicer classification.

The accelerated training will be given over the next 12 months. The necessary schools have been scheduled so that all 12 of these employees will have completed the required 320 hours of academic training by the end of May 1984. The required 1,637 hours of on-the-job training is to be provided when these employees are not involved in an academic session. All of the employees involved have accrued significant amounts of on-the-job training and academic training. The training record and projected completion of the accelerated program for these 12 employees are indicated on the attachment.

During 1984, San Francisco Division plans to add about 20 employees to this accelerated program. The 1985 requirement will be determined as the Transformer Replacement Program progresses.
