#### Gentlemen:

The following proposal pertains to our discussion on June 25, 1984 regarding the establishment of an Underground Gas and Electric Installation Crew. Please refer to my attached letter dated, July 13, 1983, regarding this subject which also includes the revised wage rate for Utility Underground Installer and Underground Installer.

We propose the continuation of the Efficiency Experiment in the Gas T&D Department throughout the Company system to November 1, 1984 based upon the understanding that either party has cancellation rights under this Agreement by giving 30-days notice.

Company will provide Union with a proposal for the establishment of appropriate conditions for continuation of underground service work and a permanent Underground Gas and Electric Utility Installation Crew to install gas and electric services, as well as data on the results of the efficiency test as soon as possible. It was agreed that Company and Union will meet to discuss this proposal at 10:00 a.m., on July 17, 1984, in our conference room at 245 Market Street.

We believe the continuation of the underground service work to November 1, is important based on the following:

- The Efficiency Experiment in the Gas T&D Department proved to beneficial and productive.
- 2. The employees involved liked the work and the results.

3. Our customers and contractors believe this procedure is much more efficient than the normal procedures. We need to capitalize on and maintain this positive image.

Dear Mr. McNally:

This letter cancels and supersedes all other correspondences submitted to you relative to the establishment of an underground gas and electric installation crew. As a result of the "204.4" meeting of May 24, 1983 and your letter of June 22, 1983, Company, pursuant to Section 204.4 of the Physical Agreement, hereby notifies Union of its intent to implement an efficiency experiment in the Gas T&D Department throughout Company's system. The experiment will consist of establishing an underground gas and electric utility installation crew to install gas and electric services and is planned to start after July 15, 1983.

The temporary classifications, wages and job descriptions consist of the following:

\$636.00 (Revised) 1041 <u>Utility UG Installer</u> (wage \$602.80 per week)

An employee who is in charge of a working unit of one to five additional employees engaged in construction work. Shall have the personal qualifications of leadership and supervisory ability, and be familiar with G.O. 112, 128, Company construction standards, safety rules and accounting requirements. Shall be skilled in the installation of electric non-lead cable systems and plastic gas distribution systems and the operation of associated construction tools and equipment.

The experimental crew will report to Gas supervision.

Before implementation, Company will conduct a training program for all employees involved in this efficiency experiment. The following is a description and schedule of the training:

#### Underground Utility Work Unit Experiment Training

#### 1. Administration:

1.1. All training, qualifying and reviewing of personnel for the underground utility work unit experiment shall be administered jointly by the Division Gas and Electric instructors.

#### 2. Required Training:

- 2.1. Two days of classroom training based on the material and instruction received at the initial two-day, non-lead splicing course, on April 6 and 7, 1983.
- 2.2. Three days of actual on-the-job training to qualify personnel in the proper installation of secondary underground services.
- 2.3 After the underground utility work unit experiment has commenced, two days of on-the-job observation and review of work procedures by the Division instructors.

As was discussed at the May 24, 1983 meeting, it was agreed that employees participating in this experiment would be on a voluntary basis. An employee at any time may request and be granted the right to return to his regular classification and duties. Further, Company agreed that no employee would be displaced, demoted or reassigned to different work for lack of work as a result of this experiment. Employees classified as UG Installer (1042) will be subject to the non-lead splicing course for the purpose of familiarizing them with the work process. However, in the assignment of duties, Note D of the UG Installer classification will govern.

During the six-month experiment, Company will parallel the experiment Division-by-Division by continuing to perform the work in the same manner that it is currently being done for the purpose of compiling data to determine if this work process increases efficiency of operations. The data will be forwarded to the Union on a weekly basis as provided for in Subsection 204.4(a) and will include the data on parallel work assignments.
