Gentlemen:

Pursuant to Section 202.2, Company proposes to change the Gas Dispatch Service Operator schedule in the San Francisco District of Golden Gate Region.

The initial sign-up for shifts will be offered to Service Operators on the basis of current San Francisco District Service Operator classification seniority. Service Operators presently on the four to midnight shifts and midnight to eight shift will have first preference for initial sign-up on shifts 8 through 12. For the purposes of this agreement, current San Francisco District Service Operator classification seniority dates will be utilized. Where classification dates of Service Operators are the same, Company seniority will be the determining factor.

The proposed schedule is described on the attached sheet. Shifts numbered 1 through 6 rotate weekly inclusively; shifts numbered 8 through 11 rotate weekly inclusively; shifts numbered 7 and 12 are static.

Either party may cancel this proposal by providing 30 days' written notice to the other party.

This proposal has been discussed with IBEW Business Representative Ed Caruso.
