Gentlemen:

Due to conditions similar to those that necessitated the establishment of Saturday coverage and coverage until 6:00 PM on weekdays in the San Francisco District Gas Department, it has become necessary to provide similar coverage for Gas Maintenance crews at Colma.

Consequently, Company intends to establish a Tuesday through Saturday workweek at Colma and to rotate such workweek among the three leak repair crews at this location.

Company proposes pursuant to Section 202.16 of the Physical Agreement to establish a late emergency crew with the hours of 9:30 AM to 1:30 PM and 2:00 PM to 6:00 PM with a one-half lunch period from 1:30 PM until 2:00 PM. The proposed hours of work will be integrated with the Tuesday through Saturday workweek rotation.
