Gentlemen:

Pursuant to Section 205.19 of the Physical Agreement, Company proposes to place Mr. Robert Burchfield, Equipment Operator, Walnut Creek, into the position of Assistant Foreman's Clerk, Walnut Creek, effective February 1, 1987.

Mr. Burchfield began his career with PGandE on October 26, 1964. While working as an Equipment Operator on June 11, 1984, Mr. Burchfield sustained an industrial injury to his back which rendered him incapable of performing physical classification work and placed him on Worker's Compensation Payroll.

On October 1, 1986, Mr. Burchfield was placed on the Rehabilitation Payroll as a Field Clerk T/A for training proposes and to evaluate his performance in this type of work. On January 1, 1987, Mr. Burchfield was transferred from his Rehabilitation Program assignment as Field Clerk T/A to a Rehabilitation Program assignment as Assistant Foreman's Clerk T/A. The reason for his assignment change was that Diablo Division could no longer project an upcoming vacancy in the Field Clerk classification; however, it did foresee a vacancy in the Assistant Foreman's Clerk classification when the current incumbent retires on February 1, 1987.

In accordance with Subsection 112.10(c) of the Physical Agreement, if placed into the Assistant Foreman's Clerk classification, Mr. Burchfield's rate of pay will be \$645.87 per week.
