Gentlemen:

The Company is converting the Eureka Gas Load Center into a 24-hour dispatch operation. In order to minimize the impact of this change on employees and to provide for a smooth transition, the following is proposed:

1. STAFFING

The current staff - three Pressure Operators, one Relief Pressure Operator and one Service Operator will remain after the conversion. The one temporary Pressure Operator will return to his regular classification of Serviceman.

The Pressure Operators are to remain in their current classification after transition. The first Humboldt Division Pressure Operator position that becomes vacant after the transition may be filled by the Relief Pressure Operator. Subsequent vacancies will be filled in accordance with Title 205.

2. ROTATING SHIFT SCHEDULE

The five employees will work a rotating shift schedule (Attachment I).

3. DUTIES

New duties, all falling within Exhibit VI definitions for Pressure Operators and Service Operators will be assigned. For this agreement only, the duties of Pressure Operators and the Service Operator will be the same.

4. TITLE 205 AND 206

The change in assigned duties will not affect these employees' current status with regard to their entitlements under Titles 205 and 206.

5. RELIEF

The Relief Pressure Operator will provide relief for both the Pressure Operators and the Service Operator. If additional relief is required, the assignment may be offered to Humboldt Division Gas Serviceman, if available based on operational needs.

6. JOINT COMMITTEE

Company and Union agree to establish a joint committee to resolve any issues that arise as a result of this consolidation.
