Gentlemen:

The Company and the Joint Apprenticeship & Training Committee request that Mr. Gino V. Rinaldi, Apprentice Lineman, San Francisco Division, who has been on the Compensation Payroll since June 1986, be advanced to the one year step of Apprentice Lineman.

Attached, as Exhibit 1, shows the history of Mr. Rinaldi and why Golden Gate Region is requesting that Mr. Rinaldi be advanced to the one year step so that he can be placed as a temporary Inspector for a three-month period and, further, with Union's agreement, be placed into an authorized Inspector position. Attached, as Exhibit 2, is the Joint Apprenticeship & Training Committee agreement to allow Mr. Rinaldi's advancement to the one year step contingent upon the conditions as outlined. We have been informed that Mr. Rinaldi has received a medical release to perform the duties of an Inspector. Therefore, may we have your agreement to 1) advance Mr. Rinaldi to the one year step of Apprentice Lineman, 2) place him in a temporary Inspector position for a three-month period, and 3) if he is successful as an Inspector at the end of the three-month trial period, that he be placed into an authorized permanent Inspector position.

If you are in accord with the foregoing and attachments and agree thereto, please so indicate in the space provided below and return one executed copy of this letter to the Company.

CARL POTEET:

Gino V. Rinaldi, Apprentice Lineman, San Francisco Division, has been on the Compensation Payroll since June 10, 1986. His employment record is as follows:

In 1988, it was determined that Mr. Rinaldi was not physically able to perform the duties of Apprentice Lineman. The Company was unable to provide him with an alternate position within PG&E and he was referred to outside rehabilitation.

Mr. Rinaldi has indicated that he is very interested in maintaining his employment with the Company. We are currently reviewing the possibility of creating an Inspector position in San Francisco Division to accommodate him.

Attainment of the one year Apprentice Lineman step is a prerequisite for the Inspector position. Since Mr. Rinaldi was placed on the Compensation Payroll one month short of attaining the one year step and because he did not work as an apprentice upon his return in 1986, he was not advanced in the program. This poses an obstacle to placing Mr. Rinaldi in an Inspector position because he is a "D" bidder with 26 employees ahead of him on the prebid list. If he were at the one year step, he would be a "B" bidder with 2 employees ahead of him.

We have contacted Ed Caruso, Business Representative, regarding a Letter Agreement to place Mr. Rinaldi as an Inspector in the Rehabilitation Program for three months then in an authorized Inspector position if he is successful in the program. Apprentice Program July 13, 1989 Page 2

If Mr. Rinaldi were advanced to the one year step of Apprentice Lineman, there would be less concern regarding the bypass of other employees on the prebid list. In light of this, we are requesting that the Apprenticeship Committee allow Mr. Rinaldi's advancement to the one year step contingent upon the following:

- o That he receives a medical release to perform the duties of Inspector.
- o That the Union agrees to his placement as an Inspector on a trial basis for three months and if successful to an authorized Inspector position.
- o That he is successful in the Rehabilitation Program.

The Company will provide Mr. Rinaldi with the necessary training to complete the one year requirements of Apprentice Lineman and to refresh the training he had received up to 1982.
