Gentlemen:

Pursuant to the provisions of Subsection 202.16(b) of the Physical Agreement, the Company proposes to extend the trial ten-hour, four-day workweek schedule for the Auburn Gas Service Department in Drum Division through November 10, 1989.

The provisions of this proposal, except for its expiration date, are consistent with those of Letter Agreement 88-129-PGE which this proposal cancels and supersedes.

The following schedule will apply to all bargaining unit employees in this department.

One Serviceman assigned Monday - Thursday One Serviceman assigned Tuesday - Friday One Serviceman assigned Monday, Tuesday, Thursday, Friday (Wednesday off)

The regular work hours will be 0700-1730.

The trial will follow the provisions of the generic ten-hour, four-day workweek schedule outlined in Letter Agreement 86-155-PGE, with the following three exceptions:

<u>Meal and Rest Periods</u> - (Replaces "Meals" paragraph of Letter Agreement 86-155-PGE.) Lunch period will normally be five hours after start time. However, the regular lunch period may be advanced or delayed up to one-half hour for any of the reasons listed in Section 202.4 of the Agreement.

Two rest periods not to exceed 15 minutes each will be permitted; one rest period is to be taken in the middle part of the first half of the workday, and one rest period is to be taken in the middle part of the second half of the workday. Lunch periods and rest periods cannot be accumulated or combined and taken together. <u>Holidays</u> - Ten hours' pay will be paid for holidays. Employees regularly scheduled to work on holidays will only work eight hours and receive ten hours' holiday (straight time) and eight hours' pay at one-and-one-half times the straight rate of pay. The provisions of Section 103.6 shall apply to holidays on an employee's non-workday (utilizing the ten-hour credit as applied in Item No. 2, Vacation, of the generic agreement).

<u>Cancellation Clause</u> - This agreement may be cancelled 30 days after written notice of such cancellation by either party.
