#### Gentlemen:

Pursuant to Subsection 202.16(b) of the Physical Agreement, Company proposes to establish a 10-hour, four-day workweek schedule for Telecommunications bargaining unit employees (including but not limited to Telecommunications Foreman, Telecommunications Technicians, Apprentice Telecommunications Technicians or related Telecommunications classifications) at San Francisco General Office, 245 Market Street, Telecommunications Department. The start date to begin concurrent with the first full pay period following agreement (Payroll requires two weeks notice). This specific agreement will be in accordance with the generic 10-hour shift agreement (R1-90-152) with the exception of the areas noted below:

### 1. AFFECTED EMPLOYEES

Employees may volunteer to work 4 - 10-hour days in lieu of 5 - 8-hour days.

## 2. SHIFT SCHEDULE

Employees have the option of working a Monday through Thursday workweek; a Tuesday through Friday workweek; or alternating bi-weekly by working Monday through Thursday one week and Tuesday through Friday the following week.

Employees who opt to work 4 -10's may determine by majority within the group the appropriate schedule provided there is an equal distribution of employees to ensure comparable Monday and Friday coverage.

#### 3. CANCELLATION

Employees may opt to revert to the 5 - 8-hour work schedule effective January 1 or July 1 each year. However, such employee may opt to change their shift schedule not more than once in each calendar year.

Either the Union or Company reserves the right to return to the five-day, eight-hour shift schedule by giving 30 days' written notice at the local level.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided below and return one executed copy of this letter to the Company.
