Mr. Roger McCulloch, Apprentice Lineman at Oakport Service Center, Central Division, Electric T&D, Oakland, has exhausted all his opportunities to retest for the basic electricity course in accordance with Letter Agreement 85-13PGE.

Mr. McCulloch's demotion rights are enumerated under Title 206.15 of the Physical Agreement, in accordance with The Guidelines for the Apprentice Lineman Training program, page four, Section "B", Subsection (c) and Paragraph G6 of the Master Apprenticeship Agreement.

Since there are no qualified prebidders to Apprentice Lineman in the headquarters, demotion unit or region, Central Division proposes to place Mr. McCulloch into the transferable (restricted) vacancy of utility worker, Gas T&D, Oakport Service Center under Title 205.12. Mr. McCulloch's employment date is October 25, 1984. There are two more senior transfer applicants to this position (see list attached). If agreement is reached the next vacancy at this location will be filled with the restricted mode.
