Gentlemen:

Company proposes the following provisional job award pursuant to Subsection 18.17 of the Office and Clerical Agreement, for the employee Carrie Davis in the Gas Transmission and Storage Department in the Gas Supply Business Unit.

Carrie Davis, currently classified as a Utility Clerk - Operating, is the senior bidder for an Operating Clerk/Typist vacancy in the same department. Ms. Davis has been on several short-term upgrades to this position but has not yet passed the Company typing test and is therefore not qualified for a regular placement to this position.

Accordingly, Company proposes, pursuant to Subsection 18.17, to award the Operating Clerk/Typist position to Ms. Davis on a provisional basis. This provisional award is to be for a six month period of time during which Ms. Davis must prepare for and pass the Company typing test. Upon the conclusion of this provisional period, the position will be re-evaluated and graded accordingly. The newly graded position will be awarded to the qualified bidder pursuant to Title 18.

Company proposes that this provisional award be made effective October 1, 1993, and expire March 31, 1994.

This proposal is to be without precedent, and is advanced solely in support of the unique circumstances present.

This proposal has been discussed with Business Representative Ed Caruso.
