Gentlemen:

The Company proposes, pursuant to Subsection 10.7 (b) of the Clerical Agreement, to establish new work hours in the Payment Processing Center effective March 7, 1994.

The Company has completed installation of an Intelligent Character Recognition Payment Processing System (referred to as the ICR system). The ICR system will improve the quality of service provided to customers and clients by greatly reducing customer payment backlogs, improving processing accuracy, and increase the daily working cash flow. The conversion to the ICR system impacts the current work processes and requires hours and shift adjustments to accommodate required work flow.

All affected employees will be given an opportunity to volunteer for new work schedules based on seniority within new work units and with respect to job classification. Any work schedules that are not filled by volunteers will be filled in reverse seniority order. All employees will be given the opportunity to volunteer for the new work schedules at the same time.
