Gentlemen:

Pursuant to Section 19.12 of the Clerical Agreement, Company proposes to relocate the 20 employees headquartered in Mission Division's Customer Services office at 39737 Paseo Padre Parkway, Fremont to Fremont Service Center located at 41800 Boscell Road, Fremont. The Boscell Service Center does not currently have a Customer Service operations in the headquarters. In addition, Company proposes to relocate the Operating Clerk-Steno from Mission Division's Service Planning office at 2177A Las Positas Way, Livermore to Livermore's Tri Valley District office at 998 Murrieta, Livermore.

As a result of the Call and Credit Center consolidations, the Company no longer needs to rent office space at the Paseo Padre and Las Positas sites. This relocation will enable us to reduce office space expenses while simultaneously enhancing our ability to better serve our customers.

The closure of the Paseo Padre office will occur on July 22, 1994. The Los Positas office will close on August 31, 1994. The names and classifications of employees impacted by this relocation are attached.

This proposal has been discussed with Jane Brunner, the Local Business Representative.
