Gentlemen:

Pursuant to Subsection 202.16(b) of the Physical Agreement, Company proposes the schedule and conditions described below for the sixth refueling outage of Unit 2 (2R6) at the Diablo Canyon Power Plant. The outage is scheduled to begin September 24, 1994.

SCHEDULE

Day employees in the Electrical Maintenance, Mechanical Maintenance, Instrument and Controls Departments will work the following schedule:

First Shift 6:30 a.m. - 5:00 p.m. Second Shift 6:30 p.m. - 4:30 a.m.

Employees in the Shift Control Technician classification may be assigned these hours on a voluntary basis.

Although not required by Title 110 of the Agreement, employees on the second shift will be provided an hourly premium equivalent to the third shift premium. All of the other provisions of Section 202.17 will apply.

Tool Clerks may be assigned to a different schedule of hours, under the provisions of Section 202.17, to provide 24 hour a day coverage.

TIME PERIOD

The provisions of 202.17 may be implemented within two weeks of the planned opening of the breaker and extend until the unit has been returned to service and has operated at or above 90 percent power for 48 hours, or until 10 calendar days from the date the breaker was closed, whichever occurs sooner.

This proposal has been reviewed by the local Business Representative.

Either party may cancel this agreement with 60 days written notice.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided below and return one executed copy of this letter to the Company.
