Gentlemen:

Pursuant to Section 3.5 of the Physical Agreement, Company proposes to waive the 30-minute automotive travel time requirement for Mr. Brett Jennings, Gas Service Representative, headquartered in Placerville, for the following reasons:

 Mr. Jennings currently resides in El Dorado Hills and requests permission to live in Roseville near his in-laws, who have a home in Roseville. This will allow his spouse to attend to her father, who is critically ill due to congestive heart disease; and mother, who just had a heart attack and is home bound.

Several options have been considered; however, Mr. Jennings' in-laws will not accept anything other than to remain in their own home. His in-laws need constant care and his spouse must be immediately available at all times to them as well as the Jennings family. This has been a hardship since December, 1993, and the Jennings are unable to continue the current circumstances much longer.

2. Mr. Jennings has held the Gas Service Representative position since March, 1992. He is the only Gas Service Representative in the El Dorado District headquartered at Placerville. His gas service work is in the El Dorado Hills area, and a Roseville residence means that Mr. Jennings will be living 15 minutes from his El Dorado Hills response area. This proposed change to 35 minutes travel time to the Placerville Service Center will not cause an interruption of the continuity of service to the customers.

3. Should Mr. Jennings vacate this position, this agreement will be cancelled and the next employee will be required to meet the Section 3.5 travel time requirement.
