Gentlemen:

In accordance with Section 206.12 of the Physical Labor Agreement, the Company proposes to extend the preferential consideration rights of Section 206.9 to Gas Service Representatives previously displaced from the Gilroy Service Center.

Gas Service Representatives along with other classifications had previously been displaced or demoted from the Gilroy Service Center located at 6th and Railroad. The Company has opted to sell the property, but will open a new facility located at the Llagas Substation nearby in January 1997. As a result, the Company will establish new Gas Service Representative positions at the Llagas headquarters.

The Company proposes to extend the preferential consideration rights to the new Llagas headquarters only to those Gas Service Representatives displaced from the 6th and Railroad headquarters. Those employees are Clark Dotson and Paul Colvin, Gas Service Representatives currently working at the Edenvale Service Center. It is understood that these employees will be granted preferential consideration under Section 205.7(a) of the Physical Agreement to the newly established Llagas headquarters if they submit prebids to this effect. In addition, any possibility of preferential consideration rights to the remaining classifications previously displaced from the Gilroy headquarters should be addressed by future discussions between the Company and Union.
