Gentlemen:

Pursuant to the enabler clauses of Sections 18.17 and 205.19, company proposes to temporarily modify certain provisions of the Job Bidding, Promotion and Transfer Procedure for the purpose of transitioning from our current bidding system to the SAP system.

The SAP system necessitates changes to the prebid/transfer numbering system, the form used to submit bids/transfers, and a new prebid/transfer directory. When the new system goes live on August 12, the old system will no longer be operational. This transition should not significantly impact current bidders as the bids and transfers currently on file will be automatically converted and remain on file unless, they are dropped for reasons listed in Subsections 18.4(g), 18.5(h), 205.4(g), 205.5(h) or due to the cancellation of a prebid code/transfer number prior to the conversion.

Under SAP, the prebid/transfer code number is four digits. There is a finite number of combinations and once a number has been used, it cannot be reused. Because of this it is very important for us not to transfer to the new system prebid/transfer code numbers that are unlikely to be used in the near future. A review of the existing directory surfaced a number of classifications and locations where there are no incumbents and no plans to fill in the near future (three months). Company has deleted those prebid/transfer numbers from the current system so that they will not be converted and use up a valuable number in SAP. If at a later date, there is a need to fill one of these positions, the vacancy will be posted as a New Job at the Headquarters pursuant to Subsections 18.4(h) and 205.4(h).

If there is a need to fill a position on a temporary basis where there is no prebid number and therefore no prebids on file, the selection of the employee to be upgraded will follow the provisions of Subsections 18.3 and 205.3 except that the employee will not be required to have a prebid on file. The employee must be qualified to perform the duties of the temporary classification as provided for in Subsection 205.3(c).

Consistent with Intent Sections 18.1 and 205.1 to "endeavor to expedite the filling of job vacancies" Company proposes between August 8 and 26, 1996 to waive the eight day time limit for having a valid prebid/transfer on file. Vacancy requests that are received between August 8 and 26 will be filled giving consideration to all valid bidders/transfer applicants without regard to the eight day requirement.

In addition, Company will not fill any new vacancies between August 9 and August 12, 1996.

The dates outlined in this agreement are based on information known at this time and may need to be adjusted as the SAP system is implemented. Such adjustments will be discussed with the Union. Either provisions of the contract will be implemented or mutual agreement for the adjusted course of action will be obtained.
