Dear Mr. McNally:

In accordance with the discussions between the parties and pursuant to Section 19.12 of the Clerical Agreement and Section 206.12 of the Physical Agreement, the following is a proposed sequence of events and timetable in the application of Titles 19 and 206 for displacing employees impacted by the Company's relocation of Computer Operations (Printing function), Customer Accounting (Bill Processing, Payment Processing, and Correspondence Management functions) and Mail Processing Center (positions supporting above functions) from San Francisco to West Sacramento and the Company's downsizing of the Payroll Section due to the implementation of SAP/BSRP.

1. Section 19.1 Notification

- a. On approximately January 23, 1997, Company will provide the following employees Section 19.1 notification and Section 19.9 rights, including Subsection 18.5(a) and 18.8(a) preferential transfer/bidding rights, to vacancies in the West Sacramento Billing Center and other vacancies in the Accounting and Computer Operations line of progression which they would be qualified for:
-All employees in the Printing, Bill Processing, Payment Processing, and Correspondence Management functions.
-The 3 junior Mail Clerk Drivers in the Mail Processing Center.
-The 2 junior Sr. Accounting Clerk II's, 6 junior Sr. Accounting Clerk I's, and 4 junior Accounting Clerks in the Payroll Section.

A list of employees impacted is included as Attachment 1.

- b. In an attempt to minimize involuntary displacements of General Office employees and to provide for additional placement opportunities in General Office, on approximately January 23, 1997 Company also proposes to provide Section 19.9 rights to all other San Francisco and Fairfield General Office employees in the Accounting and Computer Operations Line of Progression to positions at the West Sacramento Billing Center. A list of employees that will receive Section 19.9 rights under this provision is included as Attachment 2.

- c. Employees identified in paragraph 1(b) above will continue to have Section 19.9 rights until employees on Attachment 1 who still need to be displaced receive their Section 19.2 notification and displacement rights (approximately May 1, 1997).
- d. Until employees in paragraph 1(a) receive Section 19.2 notification and displacement options, the Company may only fill above entry level positions in the Accounting and Computer Operations line of progression in the San Francisco General Office and Fairfield Computer Center with employees referenced in paragraph 1(a) (see Attachment 1) exercising Section 19.9 rights.

2. Posting of New Jobs at Headquarters

On approximately January 15, 1997 the Company will post all Printing, Bill Processing, Payment Processing, and Correspondence Management positions at the West Sacramento Billing Center as new jobs at a headquarters in Bidding Unit 19. On approximately February 1, 1997 the Company will post Mail Services positions at the West Sacramento Billing Center as new jobs at a headquarters in Bidding Unit 18.

3. Control Date - West Sacramento Billing Center Vacancies

- a. The Company will establish a control date of March 3, 1997 for filling vacancies in the West Sacramento Billing Center. Bids received through the U.S. mail and postmarked on or before February 22, 1997 or received through Company mail/Bid Express by the Corporate Industrial Relations Department by February 22, 1997 will be considered timely for West Sacramento Billing Center vacancies.
- b. The Company will begin to fill West Sacramento Billing Center vacancies through Title 19 with employees exercising Section 19.9 preferential bidding rights on March 5, 1997.

4. Exhibit K Provisions

In conjunction with Letter Agreement 93-42, employees identified in paragraph 1(a) and 1(b) above will be offered the opportunity to take severance. Employees with less than one year of service will not be eligible for the severance program. The severance program window for these employees will begin approximately January 28, 1997 and end 45 days later on approximately March 14, 1997.

5. Section 19.2 Notification

- a. Subsequent to the application of Item 1 above, where further reductions are necessary in the Printing, Bill Processing, Payment Processing, and Correspondence Management functions, the Mail Processing Center, and the Payroll Section, Company will give impacted employees Section 19.2 notification and provide them a list of displacements and demotion options, including any remaining West Sacramento Billing Center vacancies. It is estimated that Section 19.2 notification will be given to impacted employees by approximately May 1, 1997.
- b. In anticipation of the movement of approximately 145 positions to West Sacramento, the Company proposes to fill all beginning clerical vacancies, except Meter Readers, in Bidding Units 1, 2, 3 (except Area 10), 18, and 19 with Hiring Hall employees so that these vacancies may be offered as displacement options to impacted employees with a 19.6 option in order to minimize the impact of displacement on employees. All positions filled with Hiring Hall employees in the Accounting and Computer Operations Line of Progression and Hiring Hall employees in entry level clerical bargaining unit vacancies, except Meter Reader vacancies, in Bidding Units 1,2,3 (except Area 10), 18, and 19 will be offered as displacement options except those hiring hall positions that will be vacated before the first physical displacement of impacted employees identified in paragraph 1(a) (approximately mid-July 1997) .

c. In preparing Subsection 19.4 options for impacted employees, the requirement that employees have 3 or more years service will be waived.

6. West Sacramento Headquarters

For the purposes of Title 19, the West Sacramento Billing Center will be considered as a separate headquarters and in Demotion Unit 11.

7. Special Allowance

Any employee currently in the Accounting and Computer Operations line of progression who voluntarily bids and accepts a job at the West Sacramento Billing Center will be entitled to a special \$2,000 allowance whether or not s/he actually moves. Acceptance of the special allowance commits the employee to that headquarters for a period of 12 months. The special allowance will apply to employees whose bids are U.S. postmarked or received by Company mail or Bid Express by February 22, 1997. Upon written request, an employee is eligible to receive the special allowance prior to their report date with the understanding that the employee is committed to the position. Employees who accept a job award and accept the \$2,000, but later decline the job award before Section 19.2 notifications are distributed, must repay the Company the \$2,000.

8. Moving Allowance

In addition to those employees who are displaced under the provisions of Title 19, those employees who exercise their Subsection 18.5(a) or 18.8(a) preferential rights and currently live more than 45 minutes or 30 miles from the West Sacramento Billing Center will also qualify for up to a \$5,000 moving allowance in accordance with the guidelines established in Section 19.8 of the Clerical Agreement.

9. Job Definitions

The Company and Union will meet in the 4th quarter of 1997 to discuss job definitions in the West Sacramento Billing Center. Until then, the Company may use Computer Operators to perform the work of Utility Machine Operators at the West Sacramento Billing Center.

10. Options in Lieu of Layoff

Employees in the Accounting and Computer Operations Line of Progression who are impacted by Title 19 will have at least one employment option, if qualified, in addition to the option to elect layoff. All full time employees shall retain full time employment opportunities.

11. Office Machine Repairman/Sr. Office Machine Repairman

All provisions of this agreement will also apply to the Office Machine Repairman and Sr. Office Machine Repairman in Customer Accounting.

12. Other Accounting Line of Progression Displacements

In the event that there are additional consolidations or reductions of employees in the Accounting and Computer Operations Line of Progression, impacted employees will receive the same provisions and special allowances included in paragraphs 7 and 8 for 12 months following the execution of this agreement. The \$2,000 special allowance will only be granted to employees who utilize 19.9 rights to relocate to the West Sacramento Billing Center. The provisions of paragraph 10 will apply to employees during the 18 month window following the execution of this agreement. The Company and Union will meet to discuss the timetable for giving Section 19.1 notification if it becomes necessary to use the provisions of Title 19 to reduce or relocate the work force.

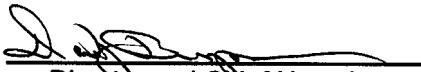
13. Future Company-Union Meetings

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.

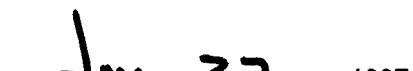
