Pursuant to the 1997 Wage Reopener settlement that was reached on June 19, 1996, the Company and Union met on August 22, 1997 and August 28, 1997, to discuss potential pension adjustments as have been provided for in the past in Special Provision G of the Benefit Agreement.

The Company and Union agreed to pension adjustments, subject to Board approval, as outlined in Attachment A. The effective date of these adjustments will be January 1, 1998.

PART III RETIREMENT PLAN

PENSION ADJUSTMENTS (Amended 1/1/[94] 98)

(a) Effective December 31, 199[3] 7, the Pension of any Participant who actually retired from the bargaining unit represented by Union or the Pension of a person receiving a Spouse's Pension or a Joint Pension, will be increased as follows (subject to Board approval):

Increase

Retired on or before 12/31/78	[9.0%]	<u>9.0%</u>
Retired between 1/1/79 and 12/31/[83] 86	[5.0%]	<u>5.0%</u>
Retired between 1/1/[84] 87 and 12/31/[89] 92	[2.5%]	<u>2.5%</u>

A minimum monthly increase of \$50 will be provided to retirees with at least 30 years of Service, and a retirement date at or after normal retirement age. A minimum monthly increase of \$25 will be provided to surviving spouses of such retirees.
