Dear Mr. McNally:

Pursuant to Section 205.19 of the Physical Agreement, Company proposes to waive Section 205.6, Forfeiture, and place Mr. Ramon Mendoza into an Apprentice Fitter position, pending completion of the Apprentice Fitter school, due to the unique circumstances noted below.

Mr. Mendoza was awarded an Apprentice Fitter position at the Edenvale Service Center on May 7, 1997. Prior to attending Apprentice Fitter school and reporting to the position, Mr. Mendoza was offered a Corrosion Mechanic position at the Cinnabar Service Center. He then declined the Apprentice Fitter position to accept the Corrosion Mechanic position which he was awarded on June 2, 1997. The Apprentice Fitter position was then awarded to the next qualified bidder, Mr. Emmanual DeLaCruz. Mr. DeLaCruz has attended and passed the Apprentice Fitter School and has been tagged into the Apprentice Fitter position. Subsequently, the Company made the decision to cancel the Corrosion Mechanic position Mr. Mendoza had been awarded.

The Company has agreed to fill an additional Apprentice Fitter position at Edenvale. Under Section 205.6, Mr. Mendoza is precluded from prebidding this position until December 3, 1997. This agreement would allow Mr. Mendoza to be placed into the position effective upon the signing of this agreement and pending his successful completion of the Apprentice Fitter School.
