## Gentlemen:

Analysis of injuries in CES indicate that the Meter Reader classification is one of two classifications experiencing the most injuries. Strains and sprains represent the majority of injuries and slips and trips are major contributors. In an effort to reduce employee injuries and pursuant to the provisions of Letter Agreement 94-53, the CES Meter Reader 94-53 Committee has proposed the piloting of a footwear allowance for Meter Readers. The provisions of this pilot are outlined below.

- 1. Meter Readers and Senior Meter Readers will receive up to a \$200 allowance in 1997 to purchase approved footwear. Approved footwear will meet the following requirements:
  - -High top or 3/4 high (above the ankle with ankle support)
  - -Leather or leather/nylon type combination uppers
  - -Non-skid soles
  - -Puncture resistant soles
- 2. The \$200 footwear allowance will be in addition to the \$45 rain boot allowance noted in Exhibit C.
- 3. All Meter Readers and Hiring Hall Meter Readers will participate in the pilot and will be required to wear approved footwear at all times. Hiring Hall Meter Readers will qualify for the allowance after 8 weeks on the Company payroll, however Hiring Hall Meter Readers will be expected to purchase approved footwear before the beginning of their second work week. Hiring Hall Meter Readers will only be eligible for one footwear allowance in 1997.

4. The pilot will continue through calendar year 1997. The Meter Reader 94-53 Committee will assess the effectiveness of the pilot at its conclusion.
