Gentlemen:

Pursuant to Section 202.16(b), the Company proposes to include the following schedule as an option under Section 202.17 for the regular Routine Plant Clerks in the Dosimetry Department at Diablo Canyon Power Plant during planned and unplanned outages:

	<u>4-10's</u>	<u>5-8's</u>
First Shift	6:30 am - 5:00 pm	8:00 am - 4:30 pm
Second Shift	12:00 pm - 10:00 pm 6:30 pm - 4:30 am	12:00 pm - 8:00 pm 8:00 pm - 4:00 am

The basic workweek of employees who are currently assigned to a 4 - 10 schedule will be either Monday through Thursday or Tuesday through Friday. The basic workweek of employees who are currently assigned to a regular 5 - 8 schedule will be Monday through Friday.

Every effort will be made to staff the shifts on a voluntary basis. Employees will not be required to work the second shifts unless there are an insufficient number of outage temporary additionals available.

Although not required by Title 110 of the Agreement, employees on the 6:30 pm - 4:30 am shift will be provided with an hourly premium equivalent to the third shift premium. Employees on the 12:00 pm - 10:00 pm shift will receive the second shift premium. All of the other conditions of 202.17 will apply.
