Dear Mr. McNally:

In accordance with the discussion between the parties and pursuant to Section 19.12 of the Clerical Agreement, the following is a proposed sequence of events and timetable in the application of Title 19 for displacing an employee impacted by the lack of Accounting Clerk work in the Corporate Accounting Department.

## 1. Section 19.1

Upon execution of this Letter Agreement, Company will provide Magdalena Cadiz, Accounting Clerk, Corporate Accounting, Section 19.1 notification. In accordance with this Section, her bids to fill vacancies in the same or lower classifications, in the Accounting and Computer Operations Line of Progression, would then be considered under the provisions of Section 19.9.

## 2. Hold of Accounting Clerk Vacancy in West Sacramento

Company will hold a vacant Accounting Clerk position in West Sacramento as an option for Ms. Cadiz to consider exercising Section 19.9 preferential bidding rights to until approximately August 11, 1997.

## 3. Section 19.2 Notification and List

On approximately August 11, 1997, Company will provide Ms. Cadiz with the list of jobs and locations to which elections may be applied, including the Accounting Clerk vacancy in West Sacramento. In accordance with Subsection 19.2(b), Ms. Cadiz will have twelve workdays after receipt of the list to notify Company of her election to transfer and indicate the job locations in the order of preference.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.
