Dear Mr. McNally:

Pursuant to Section 3.5 of the Physical Agreement, Company proposes to waive the 30 minute automotive travel time requirement for Mr. Carl Wetjen; Mr. Clinton Barnett and Ms. Jolene Clark. Mr. Wetjen and Mr. Barnett are currently Gas Service Representatives headquartered in Fresno. Ms. Clark is currently a Reserve Gas Service Representative headquartered in Fresno who is the Top "B" bidder for a Gas Service Representative vacancy headquartered in Fresno.

Mr. Wetjen has lived outside the 30 minute automotive travel time requirement since October 1993 while in the position of Gas Service Representative. Mr. Barnett has lived outside the 30 minute automotive travel time requirement since January 1995 while in the position of Gas Service Representative. The waiver of 30 minute automotive travel time requirement for both Mr. Wetjen and Mr. Barnett was done without a signed agreement between the parties. The Company believes that the current situation of both Mr. Wetjen and Mr. Barnett living beyond the travel time requirement has not caused an interruption to the continuity of service to the public.

Ms. Clark currently lives outside the 30 minute automotive travel time requirement for the vacant Gas Service Representative position heaquartered in Fresno. However, the Company believes that Ms. Clark living beyond the travel time requirement will not cause an interruption to the continuity of service to the public should she be awarded the position of Gas Service Representative in Fresno. This agreement will only apply to the three individuals stated above. In the event any one of these three individuals vacate the position of Gas Service Representative, this agreement will be canceled and the next employee will be required to meet the Section 3.5 travel time requirement.

The issues raised in grievance FRO-97-42 have been addressed by this Letter Agreement and accordingly this case is closed and settled on the basis of the foregoing.

Company and Union reserve the right to cancel this agreement by giving 30 days written notice.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.
