Dear Mr. McNally:

The Call Center Call Quality Monitoring 94-53 Subcommittee has proposed 2 pilots that would modify the Call Quality Monitoring Guidelines agreed to in Letter Agreement 98-03.

1. San Jose Call Center Pilot

San Jose Call Center would implement a 90-day pilot that would modify the agreed to call quality monitoring forms by deleting the numerical rating scale that is included on the form. The intent of this pilot is to determine whether omitting the rating scale will help employees focus on qualitative feedback versus a quantitative rating.

2. Feedback Pilot

The current provisions of Letter Agreement 98-03 provide that employees will receive copies of the call monitoring forms on the same day that they are monitored when practicable, but not later than the employee's next workday.

In some cases, operating conditions have not permitted feedback to be given on the same day as the monitoring was conducted or the next day. The Subcommittee proposes a 60-day pilot that would allow CSRs in all 4 Call Centers to voluntarily agree to add one additional shift to the timeline for

providing feedback. If the employee does not agree to the extension, the feedback will be given in accordance with the timeline in Letter Agreement 98-03 or will be discarded. The Committee will review the number of monitoring sessions that were discarded during the pilot.
