Dear Mr. McNally:

The Grid Maintenance and Construction Department in Electric Transmission located at 275 Industrial, San Carlos, is experiencing on-going turnover of employees. This turnover has reduced productivity at the San Carlos headquarters. Therefore, the Company proposes, pursuant to Subsection 204.4(b), to designate the following classifications as critical at the San Carlos headquarters in the Grid Maintenance and Construction Department in ETBU: Electric Crew Foreman, Lineman, Transmission Troubleman, and Equipment Operator.

Critical status shall be for eighteen months. By mutual agreement the "critical classification" designation may be lifted on either an individual basis or on a total basis.

Electric Transmission will seek volunteers from all employees in those classifications at the San Carlos headquarters within Grid Maintenance and Construction. Employees who volunteer will be paid 8% above their basic weekly rate as shown in Exhibit X and their prebids will not be considered for other vacancies. Employees who decline will have their position designated as critical when the position becomes vacant. Employees will have two days to decide whether to accept the critical designation. All vacancies in those classifications will be designated as critical when filled through the bidding system.

Either party may cancel this agreement upon thirty days written notice to the other party.

If you are in accord with the foregoing and agree thereto, please so indicate in the space provided and return one executed copy of this letter to the Company.
