Dear Mr. Zimmerman:

The Company proposes to change the work hours, shift schedule and wage schedule of the (0301) Control Room Assistant (CRA) classification headquartered at the Diablo Canyon Power Plant.

Staffing

Regular staffing for the CRA position under this letter of agreement will be a minimum of three employees to be scheduled as noted below. It is expected that the optimum staffing will be three employees. No employee will be displaced from the CRA position as a result of this agreement.

Rotation and Schedule

- The schedule will consist of a three-week rotating shift.
- When only two shifts are covered, they will consist of Shift Week B and Shift Week C.
- During any periods when four CRAs are staffed, the rotation will be four weeks. The sequence will be Shift Week A, Shift Week B, Shift Week C.
- One CRA may volunteer to work a permanent Shift Week C and one CRA may volunteer to work a
 permanent Shift Work A. If there are no volunteers or if there is more than one volunteer, the three-week
 rotation will be implemented.

The rotation and schedule will be as follows:

If agreed to, Company may cancel the Staffing and Rotation and Schedule portions of this agreement with 30 days advance notice. If this occurs, the 0301 Control Room Assistant classification will revert back to the schedule contained in Letter Agreement 89-209.
