Gentlemen:

The Company and Union agreed to establish a Mainman-Arc classification on April 26, 1985 (No. 85-16-PGE).

When the new classification was requested, it was determined that a Certified Welder was not required. Since that time, arrangements have been made to transfer Station S and T from the Steam Department to Golden Gate Region Steam Heating System. As a result of this change, the Steam Heating System will require a Certified Welder. It has been estimated that certified welding will require approximately 90 percent of the time of the classification, and noncertified welding will require approximately 10 percent of the time of the Mainman-Arc classification. Employees who bid to this classification must be qualified as a Certified Welder. Further, the successful bidder must successfully pass the Mainman-Arc Training Program.

Therefore, Company proposes to revise Letter Agreement 85-16-PGE to incorporate the certified welding requirement, change the job title to Certified Welder/Mainman-Arc, and change the line of progression and bidding rights of this classification.

1151 CERTIFIED WELDER/MAINMAN-ARC

An employee with the qualifications of Certified Welder and Mainman-Arc. This classification performs specialized work in connection with the installation, maintenance and operation of pipelines and other steam facilities without immediate supervision. Performs certified welding; some arc welding and other duties including complex layouts, hot tie-ins on larger diameter steam pipelines, operating mainline valves. Works alone or as part of a crew, installs, maintains and repairs steam mains and appurtenances in the steam heat distribution system. May be required to drive a truck, operate compressors and mechanical equipment such as jackhammers, tampers, and impact tools and perform clerical work associated with those duties. May be assigned to perform pipe locations and leak surveys and investigations. Performs all certified welding work as outlined in the job definition for Certified Welder (2626 and 2631).

Such work may be performed alone, but, where necessary for protection, a Helper may accompany him. While the Helper's primary function will be to act as a flagman for the protection of men; nevertheless, the Helper will be expected to provide assistance to the Certified Welder/Mainman-Arc.
