Gentlemen:

This letter cancels and supersedes our letter dated April 8, 1987 on the same subject.

Company anticipates hiring approximately 250 temporary additional employees in various beginning classifications for summer vacation relief in the Regions, General Construction and the General Office. These positions are authorized for a maximum of four months from the date of the employee's hire.

Consistent with P-RC Decision 683, Sections 19.13, 206.13 and 306.14 of the Labor Agreements, Company will offer reemployment to laid off employees as appropriate. However, because these positions are authorized for a definite limited period, Company proposes that at the end of the four-month period, these employees again be laid off without regard to the provisions or entitlements of Titles 19, 206 and 306 of the Labor Agreements and Letter Agreement 87-41-PGE.

Company also proposes to offer some of these positions to employees in the retraining pool established by Letter Agreement 87-41. At the conclusion of the temporary assignment, these employees will be returned to the retraining pool.
