The local Business Representatives for DCPP have been provided with a list of employees who have transfers on file for Materialsman. Those employees with valid transfers on file as of March 21, 1988 were contacted and have turned down the position.

The wage rates for the reclassified employees will be determined pursuant to Sections 204.5 and 204.6 of the Physical Agreement. For the purposes of shift selection, assignments will be made based on seniority. Prearranged overtime will be equalized by crediting the affected employees with one hour more than the average amount of current prearranged overtime. For emergency overtime, Section 212.6 will apply. The current vacation schedules will continue for the rest of this year.

For purposes of consideration under Subsection 205.7(b) & (c), time spent in the General Construction Material Man (1205) classification at Diablo Canyon Power Plant will be considered as time worked in the Materialsman (1210) classification. The affected employees must complete the Materials Department's training course in order to progress in the Materials line of progression.

Employees affected by this agreement are required to pass all the appropriate tests prior to being considered for subsequent positions, bids, or transfers.

It is our understanding that this proposal has been reviewed with Messrs $R.\ Van\ Dyke$ and $M.\ Haentjens.$
