Gentlemen:

The Company proposes, pursuant to Subsection 10.7 (b) of the Clerical Agreement, to establish new work hours in the Payment Processing Center effective May 1, 1995.

The Company intends to implement a Late Payment Fee for customers with a prior balance on their PG&E utility bill. Implementation of the late payment fee will impact the current work process and will require hours and shift adjustments in the extraction unit. The current "graveyard" shift which works Tuesday through Saturday will merge with the graveyard shift which works Monday through Friday. The current Monday through Friday hours will be expanded to include an earlier start time. These changes will ensure that payments are processed quickly and efficiently to alleviate wrongful late payment fee charges.

In addition, these changes require the establishment of a part-time extraction unit. The new unit will be staffed by 10 part-time employees working Thursday, Friday and Saturday, with the option of additional works hours when necessary.

The Company has changed the deposit procedures for cash processing. This change has reduced the handling cost from \$0.035 to \$0.01 per check. In order to qualify for this reduced fee, checks now have to be prepared for deposit by 10:30 a.m., Monday through Friday. This change in deposit procedure will impact the current work process and will require an hours adjustment in the deposit control/system administration unit. The current hours will be expanded to include an earlier start time.

All affected employees will be given an opportunity to volunteer for the new work schedules based on Company seniority. All employees will be given the opportunity to fill the new work schedule at the same time. In filling the new work schedule, the Company will adhere to the provisions of the agreement reached between the parties on May 3, 1978 (ref: Memo to Payment Processing Center employees dated October 6, 1987.)

All other units and work schedules will remain the same.

This matter has been discussed with Business Representative Lula Washington.
