Pursuant to Letter Agreement R3-91-20-PGE and 92-56-PGE, 95-83-PGE and Sections 204.4 and 304.4 of the Physical Agreement, Company proposes to establish the classifications and wage rates listed below for work performed during the 1R9 Refueling Outage (scheduled to begin in February 1999) at the Diablo Canyon Power Plant. Proposed wage rates for 1998 were included as some outage workers will report for training in late December.

Note: For temporary outage employment, a former employee in the re-hire pool will be utilized, pursuant to the provisions of LA 93-16, prior to an external hire in a comparable classification that such former employee held on a regular basis. Additionally, such former employee will be compensated for such temporary work at a rate not less than the rate at which he or she performed the work as a regular employee.
