Dear Mr. Zimmerman:

In order to continue meeting the workload demands resulting from the implementation of CorDaptix®, the Company proposes, pursuant to Subsection 10.7(b) of the Clerical Agreement, to temporarily establish a 4:00 p.m. - 12:30 a.m. (Monday-Friday) shift in the Sacramento Records Department at 5555 Florin-Perkins. The Company expects to fill approximately 25 Service Representative positions on this shift through the Title 18 bidding process.

There are currently 19 Service Representatives and 5 Utility Clerks performing Records work at the Florin-Perkins headquarters and all available space has been utilized. The Company has obtained additional office space at 10375 Old Placerville Road in Sacramento, which should be available within 6 months. Once the new facility is available, the Company will move the Records work and employees from Florin-Perkins under the provisions of Section 19.16. At that time, employees will return to a 7:00 a.m.-3:30 p.m. shift. Office Services work will continue to be performed at Florin-Perkins.

As vacancies on the new shift are offered, bidders will be advised that the shift is temporary and that their position will be relocated to the new facility when available.

This proposal has been discussed with Darryl Norris, local Business Representative.

This agreement may be canceled by either party upon 60 days written notice to the other of such cancellation.
