Gentlemen:

This letter cancels and supersedes our letter of March 12, 1985 on the same subject.

There is presently a vacant Blacksmith position (temporarily filled) and two Sheet Metal Worker classifications, presently filled by Messrs. Frank Montoya and James Renshaw in the Materials Distribution shop at Emeryville. It has been determined that there is an insufficient amount of work within the Blacksmith classification to justify retaining a full-time employee in this position. Job duties presently performed by the Blacksmith are required, however, to maintain an effective and efficient operation Company, therefore, proposes to eliminate the existing classifications of Blacksmith and Sheet Metal Worker and establish a new classification of Metal Worker by merging the job duties of the two existing classifications, as follows:

1455 METAL WORKER

An employee who makes and repairs articles and tools, sharpens and tempers same and does other miscellaneous jobs requiring the use of hand tools, forge, anvil triphammer, and who forms, welds, and unites sheet, rolled, cast and extruded metals, including the fabrication of jobs from plans and sketches. Must have working knowledge of metallurgy and pattern drafting. The employee's background and experience must be such that these duties can be performed with skill and efficiency.

Company also proposes to place the Metal Worker in all Lines of Progression which currently list the classifications of Blacksmith and Sheet Metal Worker. The proposed rate of pay for the classification will be the existing rates of Blacksmith and Sheet Metal Worker, which are the same.

In addition, Company proposes to retain Messrs. Frank Montoya and James Renshaw, as present incumbents only, in their current Sheet Metal Worker classification and grandfather Mr. D. Jackson into the newly established Metal Worker classification.

An apprenticeship program will be developed for this classification at a later date.
