Gentlemen:

The Company proposes, pursuant to Subsection 10.7 (b) of the Clerical Agreement, to establish new work hours in the Payment Processing Center effective September 5, 1994.

The Company has completed installation of an Intelligent Character Recognition Payment Processing System (referred to as the ICR system). The conversion to the ICR system impacts the current work processes and requires hours and shift adjustments to accommodate required work flow. These changes in hours are needed in order to meet bank deposit closing deadlines.

All affected employees will be given an opportunity to volunteer for new work schedules shift and/or unit based on Company seniority. Any work schedules that are not filled by volunteers will be filled in reverse seniority order. All employees will be given the opportunity for the new work schedules at the same time. In filling the new work schedule, the Company will adhere to the provisions of the agreement reached between the parties on May 3, 1978 (ref: Memo to Payment Processing Center employees dated October 6, 1987.)
